## **Notice from the Comptroller of Inland Revenue**

The general public is also asked to note that in respect of the above-mentioned action in accordance with section 70 of the Property Tax Act the Comptroller hereby declares:

- i. The reserved price/ upset price for each property is listed above.
- ii. That at the fall of the gavel for the auction of each property, the winning bidder must pay a deposit of at least 5% of the winning bid on the spot.
- iii. The remainder must be paid to the Comptroller of Inland Revenue within the **next 30 days** after the date of the auction.
- iv. It is to be noted that if the remainder of the winning bid is not paid within the prescribed time the deposit will be forfeited.
